**CONDITIONS OF ENTRY**

**TICKETS**

TWO free admission tickets ONLY per application will be issued. Where there are multiple applications from one Exhibitor, tickets will be allocated accordingly. Additional tickets for bona fide use of exhibitors may be purchased at the preferential rate of £8.50 each.

**INSURANCE**

Insurance is the responsibility of the individual exhibitors; therefore the Society shall not accept responsibility for loss or damage howsoever caused. Exhibitors are requested to ensure that they have Third Party Public Liability Insurance while at the Show. Please enclose copy of Certificate.

**RISK ASSESSMENT**

Please note that the Society requires a copy of a risk assessment policy. A form is available on our website – [www.derbyshirecountyshow.org.uk](http://www.derbyshirecountyshow.org.uk) Please ensure a copy is forwarded with the application form.

**SITING**

Siting shall be allotted by the Show Officers. All allotted sites must be accepted by the exhibitor and are not transferable

**ADMISSION OF EXHIBITORS' VEHICLES AND EXHIBITS**

Where possible, all exhibitors should be on the Showground and all exhibits set up as soon as possible after 8.00am. (The public is admitted to the Show from 8.00am). Exhibitors within this section will be issued with ONE Showground parking permit per vehicle. Additional Exhibitors' car park passes are available on application, free of charge. Any vehicles not forming part of the display MUST be removed to the Exhibitors Car Park before 8.00am.

**For Health and Safety reasons, we are unable to allow Exhibitors' vehicles to drive around the Showground after 9.00 am. Vehicles arriving after this time will be directed to a specially designated parking area.**

Security Officers have orders that no vehicles, other than those carrying livestock, shall be admitted to the Showground between 9.00 pm on Saturday 27th June and 6.00 am on Sunday 28th June. The Showground will be closed and secured. Kindly ensure that you arrive within your allotted time.

**LITTER**

It is the responsibility of exhibitors to control and remove litter directly accruing from their trade area. Skips shall be provided on the Showground, please do not fill the litterbins with packaging. Litter not so removed by exhibitors shall result in the cost of such removal being recoverable from the offending exhibitor. Exhibitors who leave unacceptable amounts of litter will not be invited to attend any shows in the future.

**ANNOYANCE**

The selling of goods by auction, shouting or other behaviour deemed to be annoying to visitors or exhibitors, is strictly forbidden. Exhibitors infringing this regulation are liable to have themselves and their goods ordered out of/or removed from the Showground.

**PRIZE**

A trophy will be awarded to the winners in the Vintage Motorcycle, Vintage Tractor and Stationery Engine Classes.

**LATE ENTRIES**

We will attempt to include entries after the 1st June but reserve the right not to do this should our entry be larger than anticipated.
